It is to inform you that after considering the report of the Inspection Committee appointed for the purpose, the Vice-Chancellor has been pleased to grant of provisional affiliation for the introduction of B.Sc. Part-I Computer Sciences course with intake 40 seats on self financing basis w.e.f. the session 2014-15, subject to fulfillment of following conditions imposed by the Inspection Committee: -

The college does not have sufficient number of books in the library, equipments in the lab, latest computers with internet connectivity.

In addition to the purchase of books, 20 latest computers with internet connectivity are required for the up gradation of at least on of the computer lab.

One lac for purchase of books of computer science in the first year and 50,000/- each in two subsequent year. (point no. 11(e))

The college should appoint two regular Teachers and one Technical Assistant.(point no. 12)

You are requested to take immediate necessary action on top priority basis with regard to fulfillment of above conditions as early as possible.



Sir/Madam,

This is in continuation of this office letter CBR/2015-16/8923 dated 08.05.15 & CBR/2015-16/15172 dated 8.7.15 on the subject cited above.

I am to inform you that Vice-Chancellor has allowed to your college grant of provisional affiliation for introduction of M.Com. Part-I (40 seats), PGDCA (40 seats) & Geography as elective subject in B.A/B.Sc (60-80 seats) courses on Self Finance Basis w.e.f. the session 2015-16, subject to fulfillment of the following recommendations/conditions:-

For M.Com Part-I

The college will appoint 2 teachers subject to University norms and strengthen the library with good titles and journal worth Rs. 40,000/- before the start of the session.

For PGDCA Course:-

- (i) College will appoint 2 approved faculties as per University norms and one technical Assistant.
- (ii) College will purchase 10 PC alongwith legal software as per syllabus.
- (iii) Library be strengthened by adding books worth Rs. 20,000/- before start of the session.

Geography as elective subject in B.A/B.Sc.:

1. The college should spend the additional amount worth Rs. 50,000/- for purchase of more library books.
2. The college should spend the additional amount worth Rs. 100,000/- for purchase of equipment.
3. Staff Requirement:
 - (i) Teaching : 1 to begin with
 - (ii) Non-Teaching : 1 to begin with


College must purchase basic equipments of B.A/B.Sc. Geography lab including top sheets/Aerial Photographs/ Satellite imagens.

The committee recommends the starting of subject geography in B.A/B.Sc. w.e.f. the session 2015-16.




