

MEMORANDUM OF UNDERSTANDING (MOU)

COLLECTIVELY referred to as the "Parties."

WHEREAS, Hindu Kanya Mahavidyalaya, Jind, is a renowned educational institution dedicated to providing quality education to its students in various disciplines

WHEREAS, Art of Living, Jind, is a respected organization known for its expertise in conducting meditation and stress management programs.

WHEREAS, both Parties acknowledge the importance of promoting mental well-being, meditation, positive thinking, and stress management among college students.

NOW, THEREFORE, the Parties agree to the following terms and conditions:

1. PURPOSE

This MOU shall be in effect for a period of one year commencing on the effective date mentioned above.
