

MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding (MoU) is made and entered into on this ...day of September 2023, between, Hindu Kanya Mahavidyalaya, Jind a Govt. Aided college, located at Gandhi Nagar, Jind and established under the act enacted by Director General Higher Education Haryana represented by its Principal, Dr. Punam Kajal, hereinafter referred to as the "Hindu Kanya Mahavidyalaya" of the "FIRST PARTY"

And

Bharat Vikas Parishad, Bhuteshwar Shakha, Jind represented by its President, Sh. Mohit Goyal, here in after referred to as the "Bharat Vikas Parishad" as the "SECOND PARTY"

COLLECTIVELY referred to as the "Parties."



WHEREAS:

1. HKMV is an educational institution dedicated to the empowerment and holistic development of women, providing high-quality education and fostering social responsibility among its students.
2. Bharat Vikas Parishad is a non-profit organization committed to promoting community development, education, skill development, health, social welfare, social services, community service projects, awareness campaigns, scholarships, and grants.
3. Both HKMV and Bharat Vikas Parishad share common goals and objectives in enhancing the well-being of the community and fostering social development.

NOW, THEREFORE, the Parties hereto agree as follows:

1. Purpose:

The purpose of this MoU is to establish a framework for collaboration between HKMV and Bharat Vikas Parishad in promoting community development, education, skill development, health, social welfare, social services, community service projects, awareness campaigns, scholarships, and grants.

2. Areas of Cooperation:

HKMV and Bharat Vikas Parishad shall collaborate in the following areas, but not limited to:

- a. Joint community service projects and initiatives.
- b. Organizing skill development workshops and training programs.
- c. Conducting health awareness campaigns and medical camps.

- d. Providing scholarships and grants to deserving students.
- e. Promoting social welfare activities and initiatives.
- f. Collaborating on research projects and publications.
- g. Facilitating internship and career development opportunities.
- h. Exchange of expertise, resources, and best practices.



3. Responsibilities of HKMV:

HKMV shall undertake the following responsibilities:

- a. Identifying areas of collaboration and projects.
- b. Appointing a designated representative as a point of contact.
- c. Coordinating with Bharat Vikas Parishad for the implementation of joint initiatives.
- d. Providing necessary infrastructure and facilities for activities.

4. Responsibilities of Bharat Vikas Parishad:

Bharat Vikas Parishad shall undertake the following responsibilities:

- a. Identifying resources and expertise required for collaboration.
- b. Appointing a designated representative as a point of contact.
- c. Assisting in the implementation of joint initiatives.
- d. Providing necessary resources and support for activities.

5. Funding and Resources:

The Parties agree to explore and leverage their respective resources and networks to secure funding for joint initiatives. The specific terms and conditions related to funding shall be mutually agreed upon in separate agreements for each project, subject to the availability of resources.

6. Intellectual Property Rights:

Any intellectual property developed jointly by the Parties during the collaboration shall be jointly owned, unless otherwise agreed upon in writing by both Parties.

7. Duration and Termination:

This MoU shall be valid for a period of one year from the Effective Date. Either Party may terminate this MoU by providing a written notice of 30 days in advance to the other Party.

8. Amendment and Modification:


Any amendments or modifications to this MoU shall be made in writing and mutually agreed upon by both Parties.

9. Governing Law and Jurisdiction:

This MoU shall be governed by and construed in accordance with the laws of Jurisdiction. Any disputes arising out of or in connection with this MoU shall be subject to the exclusive jurisdiction of the courts of Jurisdiction.
