

MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (MOU) is made and entered into on this 2023, between, Hindu Kanya Mahavidyalaya, a college located at Gandhi Nagar Jind, an Govt. Aided college established under the act enacted by Director General Higher Education Haryana represented by its Principal, Dr. Punam Kajal, hereinafter referred to as the "Hindu Kanya Mahavidyalaya" of the "FIRST PARTY"

And

District Bar Association Jind, represented by its President, (Mr. Devender Lohan) hereinafter referred to as the "District Bar Association" as the "SECOND PARTY"

COLLECTIVELY referred to as the "Parties."

WHEREAS,

1. The College is an esteemed institution providing education to young women, offering various academic programs.
2. The Bar Association is a recognized body of legal professionals dedicated to promoting legal education, professional development, and access to justice.
3. Both Parties recognize the importance of enhancing the understanding of law among students and the value of a collaborative partnership to achieve this objective.

NOW, THEREFORE, the Parties hereby agree to collaborate as follows:

1. Objectives:

- a. To promote legal education and awareness among the students of the College.
- b. To facilitate the professional development of students interested in pursuing a career in law.
- c. To enhance access to justice and legal aid for individuals in need within the community.

2. Activities:

- a. The Bar Association agrees to conduct regular workshops, seminars, and lectures on various legal topics at the College premises. These activities will aim to provide students with practical insights into the legal profession and foster an understanding of the law.
- b. The College will collaborate with the Bar Association to organize legal research projects, and other extracurricular activities that promote legal education and skills development.

c. Both Parties will jointly organize legal awareness campaigns, public lectures, and legal aid camps for the benefit of the local community.

3. Resource Sharing:

a. The College will provide the necessary infrastructure and facilities for hosting events, workshops, and other collaborative activities.

b. The Bar Association will share its expertise, knowledge, and resources in conducting legal workshops and seminars.

c. Both Parties will collaborate on the creation and dissemination of legal resources, including research materials and legal publications.



4. Coordination:

a. The College and the Bar Association will designate representatives as coordinators to facilitate effective communication and coordination between the two entities.

b. The coordinators will meet periodically to discuss the progress, plan upcoming activities, and resolve any issues that may arise during the collaboration.

5. Duration and Termination:

a. This MOU shall come into effect on the date first mentioned above and remain valid for a period of one year.

b. Either Party may terminate this MOU by providing a written notice of termination at least thirty days prior to the intended date of termination. However, such termination shall not affect ongoing activities or obligations already committed to.

6. Amendments:

a. Any amendments or modifications to this MOU shall be made in writing and agreed upon by both Parties.
