

## MEMORANDUM OF UNDERSTANDING (MoU)

And

Guru Nanak Khalsa College, Karnal a Govt. aided college established under the act enacted by Director General Higher Education Haryana represented by its Principal, Dr. Gurinder Singh, hereinafter referred to as "Guru Nanak Khalsa College, Karnal " as the "SECOND PARTY"

COLLECTIVELY referred to as the "Parties."

WHEREAS, Hindu Kanya Mahavidyalaya, Jind, is a renowned educational institution dedicated to providing quality education to its students in various disciplines.

Both institutions recognize the importance of academic collaboration and cooperation for the betterment of the welfare of their students and the enhancement of the overall educational experience.

### OBJECTIVES:

The primary objectives of this MoU are:

1. To promote academic and cultural exchange between Hindu Kanya Mahavidyalaya and Guru Nanak Khalsa College, Karnal.
2. To collaborate on organizing educational lectures, workshops, seminars, and other academic activities.



3. To facilitate faculty exchange and collaboration on research and teaching.
4. To strengthen the educational and academic resources of both institutions.
5. To engage in joint initiatives aimed at the betterment of student's welfare.

### **TERMS OF AGREEMENT**

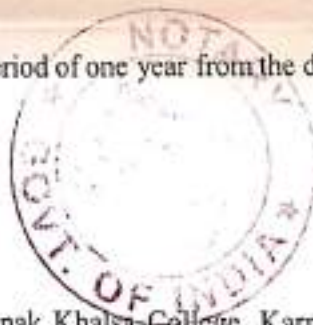
1. **Collaborative Educational Activities:** Both institutions agree to collaborate on organizing educational lectures, workshops, seminars, and other academic activities for the benefit of students. These activities may include joint academic projects, symposia, and cultural exchanges.
2. **Faculty Exchange:** Hindu Kanya Mahavidyalaya and Guru Nanak Khalsa College, Karnal agree to facilitate faculty exchange programs, where faculty members from one institution may visit the other for teaching, research, seminars, quality sustenance or other academic activities.
3. **Student Engagement:** Both institutions will encourage and support student participation in collaborative programs, workshops, and seminars organized by either institution.
4. **Resource Sharing:** The institutions may explore opportunities for sharing educational resources, such as library access and research facilities, to benefit their respective academic communities.
5. **Duration:** This MoU shall be in effect for a period of one year from the date of signing.

### **RESPONSIBILITIES**

Both Hindu Kanya Mahavidyalaya and Guru Nanak Khalsa College, Karnal will appoint a designated liaison officer to facilitate communication and coordination between the institutions. The liaison officers shall be responsible for implementing the terms of this MoU.

### **CONFIDENTIALITY**

All information shared between the institutions as part of this MoU shall be treated as confidential unless both parties agree otherwise in writing.





**AMENDMENTS**

Any amendments to this MoU must be made in writing and signed by both institutions.

**DISPUTE RESOLUTION**

Any disputes arising from this MoU shall be resolved through amicable negotiations between the institutions.
