MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding (MoU) is made and entered into on this 25th day of May. 2023, between, Hindu Kanya Mahavidyalaya, a college located at Gandhi Nagar Jind, an Govt. NOW, THEREFORE, the Parties hereby agree to the following terms and conditions:


1. PURPOSE:

The purpose of this MoU is to establish a framework of cooperation between HKMV and IPS to enhance educational opportunities, promote academic excellence, and foster educational development.

2. SCOPE OF COLLABORATION:

The Parties shall collaborate in the following areas:

- a) Exchange of knowledge and expertise in teaching methodologies, curriculum development, and assessment techniques.
- b) Sharing of educational resources, including books, research materials, and digital resources, to supplement the learning process.
- c) Organizing joint workshops, seminars, and conferences on relevant educational topics for the 12 7 SEP 2023 benefit of students, faculty, and staff.



- e) Joint research and development initiatives to advance educational practices and pedagogy.
- f) Sharing best practices and experiences in student counseling, career guidance, and co-curricular activities.
- g) Collaborating on community outreach programs to promote social responsibility and community engagement.

3. RESPONSIBILITIES OF THE PARTIES:

- a) HKMV shall provide guidance and support to IPS in areas related to women's education, gender sensitization, and empowerment.
- b) IPS shall extend support to HKM in initiatives aimed at promoting academic excellence and comprehensive educational opportunities.
- e) Both Parties shall actively participate in joint initiatives, contributing their expertise, resources, and facilities as necessary.
- d) The Parties shall appoint focal points to coordinate and monitor the collaboration activities.

4. CONFIDENTIALITY:

Any confidential information shared between the Parties in the course of this collaboration shall be treated with utmost confidentiality and shall not be disclosed to any third party without prior written consent.

5. DURATION AND TERMINATION:

This MoU shall come into effect on the date first written above and shall remain in force for a period of three years. Either party may terminate this MoU by providing a written notice of termination to the other party thirty days in advance.

6. AMENDMENTS:

Any amendments or modifications to this MoU shall be made in writing and duly signed by authorized representatives of both Parties.

7. GOVERNING LAW:

This MoU shall be governed by and construed in accordance with the laws of jurisdiction.
