

MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (MOU) is made and entered into on this 2023, between, Hindu Kanya Mahavidyalaya, a college located at Gandhi Nagar Jind, an Govt. Aided college established under the act enacted by Director General Higher Education Haryana represented by its Principal, Dr. Punam Kajal, hereinafter referred to as the "Hindu Kanya Mahavidyalaya" of the "FIRST PARTY"

And

Naresh Jaglan, Psychologist (Under Rehabilitation Council of India, New Delhi), CRR No. A16208, hereinafter referred to as "Naresh Jaglan." as the "SECOND PARTY"

COLLECTIVELY referred to as the "Parties."

WHEREAS, HKMV is an esteemed educational institution committed to provide holistic education to its students; and

WHEREAS, Naresh Jaglan is a licensed psychologist specializing in mental health and well-being, equipped with expertise in providing counseling services and educational programs to address issues such as stress, anxiety, depression, and personality development;

NOW, THEREFORE, both parties agree to collaborate and support each other in the following areas:

1. Provision of Counseling Services:

- a. Naresh Jaglan agrees to provide counseling services to the students of HKMV who require assistance with mental health concerns.
- b. HKMV agrees to facilitate a dedicated space on its premises for counseling sessions, ensuring privacy and confidentiality.

2. Educational Programs:

- a. Naresh Jaglan agrees to conduct educational programs, workshops, and seminars aimed at promoting mental health and well-being among the students of HKMV.
- b. HKMV agrees to assist in organizing and promoting these programs to ensure maximum participation and benefit for its students.

3. Collaboration and Referrals:

- a. HKMV and Naresh Jaglan agree to collaborate closely, exchanging information and insights to enhance the effectiveness of counseling services and educational programs.
- b. Naresh Jaglan agrees to refer students to appropriate external resources or specialists if their needs exceed the scope of services provided by Naresh Jaglan.

4. Duration and Termination:

- a. This MOU shall come into effect on the date first mentioned above and remain valid for a period of one year.
- b. Either Party may terminate this MOU by providing a written notice of termination at least thirty days prior to the intended date of termination. However, such termination shall not affect ongoing activities or obligations already committed to.

5. Confidentiality:

- a. HKMV and Naresh Jaglan shall maintain strict confidentiality regarding any personal information shared during counseling sessions or educational programs, in compliance with applicable laws and professional ethics.

6. Governing Law:

- a. This MOU shall be governed by and construed in accordance with the laws of Jurisdiction.

7. Amendments:

- a. Any amendments or modifications to this MOU shall be agreed upon in writing and signed by both parties.
